## AIRCRAFT RENTAL AGREEMENT

In consideration of the rental fees paid and the covenants contained herein, Destin Flight Works LLC, hereinafter referred to as the "Operator," hereby leases to the "Renter" the designated aircraft hereinafter referred to as the "aircraft."

- A. Renter acknowledges and agrees that the aircraft is the property of the Operator.
- B. Renter acknowledges that he has inspected the aircraft and has found it to be in good mechanical condition and airworthy.
- C. Renter agrees to return the aircraft at the scheduled time, weather permitting.
- D. Renter agrees to properly secure the aircraft after each flight.
- E. Renter expressly acknowledges personal liability to pay Operator on demand:
  - Service and time charges computed at the applicable posted rates until said aircraft is returned to the Operator.
  - Any loss or damage to the aircraft, its components, parts or equipment during the rental period.
  - The amount of any parking, tie-down, or hangar charges until the aircraft is returned to the Operator.
- F. Renter agrees not to tamper with, molest, or attempt to repair any parts of the aircraft or its accessories, but will telephone the Operator for instructions upon encountering mechanical malfunctions.
- G. If the aircraft is abandoned away from the home base airport, the Renter will be charged pilot expenses plus flight time at dual rates to return the aircraft to home base.
- H. Renter agrees to report any aircraft damage, accident or incident to the Operator as soon as possible.
- I. Renter agrees that rented aircraft shall not be used or operated:
  - For any illegal purposes.
  - In any race, speed test, or contest.
  - By any person other than the Renter who signed the agreement.
  - Outside the limits of the Continental United States.
  - To carry passengers or property for compensation or hire.
  - For any flight for which the Renter is not properly rated or certified.
- J. Renter agrees to reimburse the Operator in the event suit is instituted by the Operator to recover possession or to enforce any of the terms, covenants, and conditions hereof, or to collect any sum of money, damages, or cost and reasonable attorney's fees incurred by the Operator in such suit or suits.
- K. Renter, by affixing his signature hereon, does agree to follow the following flight operations safety rules, emergency maintenance procedures and insurance provisions.

## OVERNIGHT RENTAL POLICY

Any renter that rents any Destin Flight Works aircraft for an overnight out of town trip agrees to pay a minimum of 4 hours per day for the time the airplane is away from Destin Flight Works.

## FLIGHT OPERATIONS SAFETY RULES

**Pilot Certificate** – Renter must hold a valid and current pilot certificate with appropriate ratings. The person named on the rental contract shall be the pilot in command. The Renter will fly the aircraft from the left seat, and he/she will be responsible for the aircraft and its operation at all times.

**Currency** – Renter must possess evidence of a current biennial flight review, medical certificate, and aircraft checkout by a pilot designated by the Operator.

**Preflight** – Renter will personally conduct a preflight inspection of the aircraft as prescribed by the manufacturer. Renter shall use the manufacturers recommended pre-takeoff, cruise and pre-landing checklists.

**Weather** – Renter shall plan to operate the aircraft only when the present and forecasted weather indicates VFR conditions local and end route (ceiling of at least 3,000 feet and visibility 5 miles or greater) unless Renter is instrument rated, current for IFR and specifically approved by the Operator for IFR flight.

**Take-off and landing area** – No take-off or landing shall be made on any area other than the runways of an airport designed, constructed, maintained, and used as an airport with PAVED runways of no less than 2,000 feet.

**Physical conditions** – Renter shall not operate the aircraft for a period of at least 12 hours after using intoxicating substances such as liquor, tranquilizers or sleeping aids.

The Renter has received, reviewed, understands and will comply with the Destin Flight Works Standard Operating Procedures

The Renter will comply with all local, state and federal regulations.

## TRANSIENT MAINTENANCE POLICY

At Destin Flight Works, we make every effort to keep our fleet of rental aircraft in excellent mechanical condition. However, an occasional breakdown may occur while away from our facility. The following policies regarding the level of reimbursement for repairs while the aircraft is away from the Destin Executive Airport (KDTS) will apply should a breakdown occur.

In the event of a breakdown, notify the Operator of the problem immediately. If maintenance personnel are not available leave your name, aircraft number and telephone number where you can be contacted.

Do not authorize any repairs to be made to the aircraft without clearance from the Operator's representative. Failure to do so could result in the Renter being responsible for a portion of the bill.

The Operator will not reimburse the Renter for any overtime charges, call-out fees, or any other after-hours charges made by the maintenance facility. Other expenses incurred by the Renter as a result of a mechanical delay such as rental cars, hotel rooms, meals, airline fare, etc. will not be reimbursed.

The Operator will reimburse the Renter for fuel purchased, based on the local rate (up to \$3.75), provided that the Renter presents a fuel receipt from the place of purchase that shows the number of gallons.

All repairs and fueling will be made by properly licensed facilities and personnel.

## **NOTICE OF INSURANCE COVERAGE**

As a Renter of an aircraft, the undersigned Operator hereby provides notice that:

You are insured under a policy or policies of insurance provided by the undersigned Operator and providing liability coverage in the following amount: \$1,000,000.00 each occurrence, with passenger legal liability sub-limited to \$100,000.00 each passenger.

You are insured under a policy or policies of insurance provided by the undersigned Operator for a limit of \$100,000.00 per person in respect of Bodily Injury each occurrence. Student and Renter liability is \$100,000.00 each occurrence.

AIRCRAFT PHYSICAL DAMAGE INSURANCE has a deductible of \$5,000.00 which will be the responsibility of the Renter to pay to the Operator in the event of a claim. In addition, the Renter shall pay the Operator \$40 per day that the aircraft is out of service for repairs.

Renters are encouraged to consider purchasing an "Aircraft Renters Insurance Policy" from an independent insurance company to protect themselves in situations where they may be found to be negligent or responsible for damages.

## Release of Liability/Indemnification/Insurance Agreement

In consideration of being permitted to rent, lease, pre-flight, pilot, fly in and/or post-flight aircraft owned, maintained and/or operated by Destin Flight Works, and/or rented or leased from Destin Flight Works, the undersigned acknowledges and agrees as follows:

I acknowledge and understand that pre-flighting, taxiing, piloting, flying in and/or post-flighting involve risks that may result in injury, disability, or death and that I accept those risks.

To the fullest extent permitted by law, I knowingly assume any risk of loss or damage to property, personal injury, disability, or death that may be sustained by me as a result of pre-flighting, taxiing, piloting, flying in and/or post-flighting aircraft owned, maintained, and/or operated by Destin Flight Works, and/or leased from Destin Flight Works.

To the fullest extent permitted by law, I waive, release, and discharge Destin Flight Works and its parents, subsidiaries, owners, members, shareholders, directors, officers, instructors, employees and agents (collectively, "Destin Flight Works") from any and all responsibility and liability of any nature whatsoever for loss or damage to property, personal injury, disability, or death that may be sustained by me as a result of pre-flighting, taxiing, piloting, flying in and/or post-flighting aircraft owned, maintained, and/or operated by Destin Flight Works.

To the fullest extent permitted by law, I agree to defend, indemnify and hold harmless Destin Flight Works for any claims or suits brought against them as the result of any actual or alleged, willful misconduct, fault, errors, omissions or negligence of me or those operating the aircraft under my instruction, control, care or supervision.

I further agree to maintain or caused to be maintained, at my expense, Non-Owned Aircraft Liability insurance in an amount not less than \$1,000,000, including sub-limits of liability for passengers of not less than \$100,000. I further agree to maintain or caused to be maintained, at my expense, Non-Owned Aircraft Physical Damage insurance in an amount not less than:

- \$100,000 for the Cessna 150
- \$150,000 for the Cessna 172M models
- \$200,000 for all other aircraft

Such coverage shall also contain a deductible insurance provision for Non-Owned Aircraft in an amount not less than \$5,000. I agree that I shall in all instances be solely obligated to satisfy any deductible that may be applicable on the rented / lease aircraft as well as all self-insured retentions that may be applicable to any claim under the insurance I am required to maintain under this Agreement. I further agree that all such insurance required by this agreement shall be on a primary/non-contributory basis. Further, I agree to produce a certificate of insurance issued to Destin Flight Works evidencing my non-owned aircraft coverage in accordance with the required limits established in this contract.
